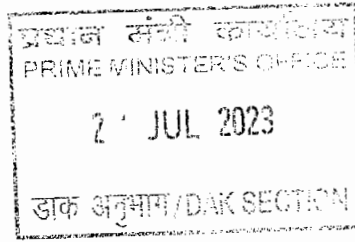

Dear **Respected Sir**, I want to inform you that I have written multiple letters directly to the Ministry of Health & Family Welfare and the National Medical Commission regularly since last more than 1.5 years; to know the actual interpretation of various sections of Gazette Notification - Foreign Medical Graduate Licentiate Regulations, 2021 dated 18th November, 2021.

In absence of the proper interpretation of the Foreign Medical Graduate Licentiate Regulations, 2021 dated 18th November, 2021; the future of thousands of Indian Medical Aspirants is at risk.

**Incase we do not educate these students today; they will loose time, money and the country huge foreign exchange.**

Educate them before going abroad; by educating them on return whole country will be loser.

A proper advisory in simple language (not legal language) from the National Medical Commission or the Ministry of Health and Family Welfare will save all the students, their parents and the country from serious problems expected to come up in future.

An advisory in simple language (not legal language) from the National Medical Commission or the Ministry of Health and Family Welfare giving answer to THREE questions as described below can save thousands of students from being misled to various destinations abroad and saving a huge Forex of the Country as well.

#### DESCRIPTION REFERENCE NO. 01

**"The National Medical Commission Gazette Notification;** dated the 18th November, 2021; No. UGMEB/NMC/Rules & Regulations/2021/" reads -

**4. Grant of permanent registration to Foreign Medical Graduate.**--No foreign medical graduate shall be granted permanent registration, unless he has -  
(b) Registered with the respective professional regulatory body or otherwise, competent to grant license to practice medicine in their respective jurisdiction of the country in which the medical degree is awarded and at par with the license to practice medicine given to citizen of that country;

#### QUESTION NO. 01

What does clause 4(b) mentioned in FMGL 2021 referred above mean -

1. He or she must be registered as a medical practitioner in the country abroad  
OR
2. He or she must be eligible to register as a medical practitioner in the country abroad  
OR
3. His / her Degree must be Registrable in the country abroad  
OR
4. He or she must possess License to Practice as junior doctor  
OR
5. He or she must possess License to Practice as independent practitioner  
OR
6. Anything else may kindly let us know the same please for the information and benefit of Indian students.

#### DESCRIPTION REFERENCE NO. 02

This has reference to **"The National Medical Commission Gazette Notification;** dated the 18th November, 2021; No. UGMEB/NMC/Rules & Regulations/2021/" that reads -

**4. Grant of permanent registration to Foreign Medical Graduate.**--No foreign medical graduate shall be granted permanent registration, unless he has--  
**(a) (ii)** Undergone an internship for a minimum duration of twelve months in the same foreign medical institution;

**ABOUT INTERNSHIP ABROAD** - confusion has been created by many while explaining students about the Practical Training / Clinical Rotation/ Clerkship / Internship in CIS countries like Russia, Georgia, Armenia, Azerbaijan, Belarus, Kazakhstan, Kyrgyzstan, Moldova, Tajikistan, Turkmenistan, Ukraine, Uzbekistan etc.

The problem is the same in all these countries; where the Practical Training/ Clinical Rotation/ Clerkship is now called INTERNSHIP and is said to be Integrated with the main course between 3rd to 6th year of education.

FAQ's were issued for explanation on internship BUT with the remarks - "these are only the nature of explanation without legal validity"; and these words in FAQ's (without legal validity) are being misused by many to misguide the aspiring students.

#### QUESTION NO. 02

The National Medical Commission must tell the aspirants if this integrated internship being done during the main course from 3rd to 6th year (practical training/ Clinical Rotation/ Clerkship) of education as mentioned by various Indian Embassies Abroad in their advisories is valid as desired Internship for licensing in India or not.

#### DESCRIPTION REFERENCE NO. 03

"The National Medical Commission Gazette Notification; dated the 18th November, 2021; No. UGMEB/NMC/Rules & Regulations/2021/" reads -

##### SCHEDULE-I

(See regulation 4)

#### CRITERIA TO RECOGNISE FOREIGN MEDICAL GRADUATES APPLYING FOR LICENCE OR PERMANENT REGISTRATION TO PRACTICE IN INDIA

2. Eligibility for primary medical qualification in a country outside India:

(iv) **Duration of course:** The total duration of the foreign medical graduation course shall be completed within ten years from the date of joining the course.

#### QUESTION NO. 03

What does **THE TOTAL DURATION OF THE FOREIGN MEDICAL GRADUATION COURSE** required to be completed within 10 years from the date of joining mean -

1. Undergraduate Degree Course abroad.

OR

2. Undergraduate Degree Course + Internship Abroad.

OR

3. Undergraduate Degree Course + Internship Abroad + Registration / License Abroad.

OR

4. Undergraduate Degree Course + Internship Abroad + Registration / License Abroad + NeXT 1 in India + CRMI internship in India.

OR

5. Undergraduate Degree Course + Internship Abroad + Registration / License Abroad + NeXT 1 in India + CRMI internship in India + NeXT 2 in India.

OR

6. Anything else may kindly let me know the same please for the information and benefit of Indian students.

To save these aspirants from such a situation, I request the Ministry of Health & Family Welfare and the National Medical Commission to answer the above three questions for the benefit of the whole country.

**Fresh admissions are on & approximately 15000 to 20000 students are expected to fly in near future.**

The Ministry of Health & Family Welfare and the National Medical Commission need to act fast to issue instructions (answer the above questions through a public notification in a simple language) to stop more innocent students from being misled and their career spoiled.

Looking at the Gazette Notification and other rules & regulations governing medical education in India and Abroad if the National Medical Commission does not educate the aspiring doctors today and reject the degree or degrees of the students on return, like first batch under FMGL2021 in 2027 calculating at 15000 students per year there will be a loss of **1,890,000,000 USD** of **FOREX** to the India between 2021 to 2027.

To save these aspirants from such a situation, I request the Ministry of Health & Family Welfare; the National Medical Commission; Indian Missions abroad to coordinate together to educate the students.

Kindly advise the Ministry of Health & Family Welfare; the National Medical Commission; Indian Missions to save our country from a bigger disaster in making.



**PUBLIC NOTICE**


**Subject :Advisory/alert for Indian students seeking admission in foreign Institutes/Universities for Undergraduate Medical Courses – reg.**

National Medical Commission published Foreign Medical Graduate Licentiates (FMGL) Regulations '2021 in the official gazette of India vide notification dated 18.11.2021 wherein the terms of duration of the study, medium of instructions, syllabus, clinical training or internship/clerkship etc. are prescribed. These conditions are mandatory for registration to practice allopathy in India.

2. It has been observed that the Institutes or Universities abroad are following the curriculum, time frame and training imparted to the students are not in consonance with NMC regulations being followed in India. Therefore, all the students who are desirous to obtain the medical qualification from any foreign medical institutions or universities and thereafter practice allopathy in India, are hereby advised to ensure that all conditions prescribed in FMGL are fulfilled before taking admission.

3. Any variation in duration, medium of instructions, syllabus, clinical training or internship/clerkship may lead to disqualification in grant of registration in India. In case of disqualification, the sole responsibility shall lie upon the candidate only.
