I will like to draw your attention towards the fact that most of the aspiring Medical students, those go to study abroad are not from rich families; but from middle & lower middle class families.

Respected Sir,

- These students join institutions abroad on the feedback & guidance given to them & their parents by Medical Education Consultants.
- ✓ These students join institutions abroad on the feedback & guidance received from the Medical Universities Abroad.
- Unfortunately there is no available Indian official or reliable source from where they can get proper information & guidance to fulfill their dream from a proper place and institution.
- ✓ These students need proper guidance from some one to tell them what is good or bad for their future and there is nothing better than the Government of our own country through National Medical Commission.
- ✓ We need to have a wing or division in NMC to guide such aspiring Medical students with the facts about the various institutions abroad; these students can be better doctors if guided to a proper place and institution.

Respected Sir, I want to draw your attention towards few things

POINT NO. 1

Respected Sir, after the announcement of the Gazette Notification Foreign Medical Graduate Licentiate Regulations 2021 aspiring medical students are being confused by the interpretation of various sections of Gazette Notification by various individuals or organizations & education consultants.

Though on 22.02.2022 NMC issued FAQ'S on various points in Gazette Notification but

Do Head on

- 1. Education Consultants respond to existing students studying abroad as well as aspiring new students with the explanation of various sections of the Gazette that suits them (Education Consultants); Especially Section 4 (b) of Gazette Notification Foreign Medical Graduate Licentiate Regulations 2021 about Registration as Medical Practitioner Abroad.
- 2. Medical Institutions abroad too respond with answers that suit their pockets and their country.
- 3. Few Indian Missions abroad do respond with good information; but if asked questions to clarify anything from their reply, they ask to seek further confirmation from National Medical Commission, New Delhi.

I BELIEVE THAT REPLY FROM ALL THE ABOVE ARE CORRECT

4. Many of the Indian Missions abroad simply say they do not know and we must approach the Medical Institutions Abroad Directly.

Such an answer is surprising; question arises, how I can know about the details of Medical Education in any foreign country while I am in India. While the officials working in that particular country do not have any information; how can I have? I believe we have an Education Officer in each Embassy Abroad.

5. National Medical Commission responds to queries from any one with the remarks to go through the Particular Section of NMC Act.

(A step motherly reply to our own countrymen, NMC does know that their reply can not be understood by the applicant, who intends to be a Doctor & has studied Physics, Chemistry & Biology NOT LAW).

Respected Sir, these sections are already mentioned on the NMC website or the Gazette Notifications; any one files RTI or writes to NMC to know the meaning of that Section in simple words to be understood by all, but they never ever get it.

National Medical Commission Website says – "The public at large is advised that before taking admission in MBBS or its equivalent course in a university outside India, confirmation of the fee structure, details of the course (which should be commensurate with the MBBS courses in India such as content, duration and internship) etc. should be directly obtained from the University/Institution concerned".

Respected Sir, Can we really believe University/ Institution concerned for such crucial information when we know that they want more & more students for more money? Something is required to be done on this to guide our students.

Respected Sir, the aspiring doctors are required to be guided in simple language only by a reliable source that can not be anything other than - The Govt of India or the Health Ministry or the Indian Missions Abroad; Above all National Medical Commission.

POINT NO. 2 - UKRAINE RETURNED STUDENTS

Respected Sir, Ukraine returned students were in Ukraine for their studies and they are not responsible for the War that is the reason you have saved their Lives. Thank you very much for saving their lives.

Respected Sir, these Ukraine returned students are being looted & misguided by the Education Consultants for taking transfer to various other countries to make quick money without proper guidelines from National Medical Commission.

These students are pressurized, misguided & motivated by many education consultants to seek transfer to various institutions abroad; but honestly neither the consultant nor the student or their parents are sure about the recognition of the institution or the degree awarded by these institutions.

Education Consultants are making students sign undertaking that they know about the National Medical Commission Act & law in India & they are taking the admission abroad by their own choice; though I propose that the Education Consultants must give indemnity bond to students about recognition of degree in India.

To make it sure for these innocent students, many like me filed RTI Applications to -

- ✓ National Medical Commission, New Delhi.
- ✓ Various Embassies of India in Abroad.

Unfortunately National Medical Commission never gave a proper reply.

India Embassies or Consulates Abroad are giving varied answers to different applications; many have told to confirm from Medical universities abroad (can not be trusted) or National Medical Commission (only reliable source).

Yes, ONLY National Medical Commission can be the best agency to give such information to students for the benefit of our country & countrymen.

One simple advisory from National Medical Commission can stop big confusion:-

- 1. Whether Ukraine returned students can take transfer to other countries or not?
- 2. Whether Ukraine returned students, those were studying Medical Education Course of 6 years duration can seek transfer to countries or institutions teaching Medical Education Course of 5 years duration?
- 3. Clarification is required on Registration as medical practitioner in abroad as mentioned in Section 4 (b) of Gazette Notification Foreign Medical Graduate Licentiate Regulations 2021.

- a. Many of the Education consultants explain to students that the Registration as Medical Practitioner is required from the same country awarding the degree before coming back to India.
- **b.** Many of the Education consultants explain that the Registration as Medical Practitioner **is NOT required** from the same country awarding the degree before coming back to India after completion of degree; but the degree holder must be eligible to get registration in a country abroad awarding the degree.

This multiple interpretation of Section 4 (b) of FMGL Regulations 2021 can be disastrous for students; so needs actual & proper interpretation in SIMPLE LANGUAGE by National Medical Commission, New Delhi to stop misuse.

In absence of such an advisory from National Medical Commission on the above many students can face problem for registration as medical practitioner in India.

Respected Sir, I humbly request you to kindly instruct concerned Departments to work on a "War Footing" and look into the matter and **give a clear easy to understand clarification for the common man**, before the declaration of the NEET results, on the various points raised by me.

This will help all including those unfortunate students who could not get seat in an Indian Medical College to pursue Medical Education Abroad.

This will also put a stop to those unscrupulous Consultants from misguiding the Students and ruining their career.

It will also do well, if the Indian Embassy in every Country is asked to personally visit and verify the Infrastructure and teaching faculty of every University. The list can be uploaded in the NMC Website, as Universities approved by NMC.

This action will help the Students as a guide as to where to seek admission.
